THE ITEMS LISTED BELOW APPLY TO ALL USAGE	
Camp Use Application	Application Forms are available at the Council office and must be submitted w/ fees (2) two weeks prior to rental or usage reservation date. All Out of Council units and/or non Scout groups must submit with the application, a proof of insurance or Hold Harmless Agreement.
Camp Use and Rental Fees	Must be paid in full and submitted with the Camp Use Application form (2) weeks prior to the reservation date. Fees are not refundable, but may be transferred to another date or camp, providing notice is given (2) two weeks prior to original reservation date. A \$20 late fee will be added to the cost for applications and payments not received (2) two weeks prior to the Camp Use or Rental reservation date.
Unit Roster and Camp Rules	Forms are part of the application and are available at the Council office. Both forms must be completed, signed and delivered to the Camp Ranger, upon arrival at camp.
Fire Wood	IS NOT PROVIDED. You may collect any downed and dead wood found on the camp property to cut with axe or bow saws (please follow the Guide To Safe Scouting procedures); or bring firewood with you. Chainsaws are prohibited.
Drinking Water Showers	During off-season use from September thru June is maintained and available at designated locations - Kingsley and Russell only. For off-season group usage from June 1 to October 1 are available. There is a \$2 / person / day fee charged for the use of these facilities.
Russell Dining Hall Kingsley Dining Hall	Equipped with gas unit heaters, wood stove insert, flush toilet (June 1 - Oct. 1), electric lights, running water and basic kitchen utensils. Equipped with gas furnace, electric lights, basic kitchen utensils along with running water and flush toilets (June 1 - Oct 1).
3-Day Weekends/Holidays Weeklong Use	There is a 50% regular fee surcharge for each additional day of use. (A day is defined any part of a requested day of use) Weeklong use is to be arranged through the Scout Service Center.
*** Metered Propane Fees	*** All facilities marked with an asterisk will have a METERED propane usage fee. They either have heating or cooking or both by propane. Your group will be invoiced for the metered amount of propane consumed at the current market cost to the Council. Invoice must be postmarked paid within 15 days of the date of issuance or credit card will be assessed.
Family Site (Russell Only)	Family Sites*** - includes water and electric and can be used by camping trailers (no sewer hookup or dumping available).
A credit card is required for use as security for the rental of any canoes, canoe trailers, lodges and dining halls by all in council, out of council and non scout groups. A Damage Deposit is required and charges will be incurred at the bid repair price for any and all damages incurred and repairs required. This card will also act as a retainer for metered propane fees, if fees are not paid within the stated timeframe, cited above, they will be applied to the Credit Card used to secure facility rental.
